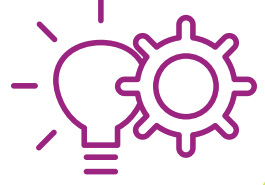


# CASE STUDY:

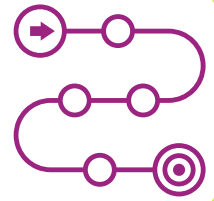
